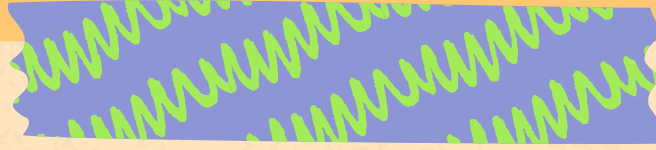

Introduction

We collect the following types of information:

Information You Provide Directly

- Email address when you subscribe or contact us*
- Wallet address when participating in the \$PEPA token presale or staking*
- Any personal details voluntarily submitted via contact forms or communications*

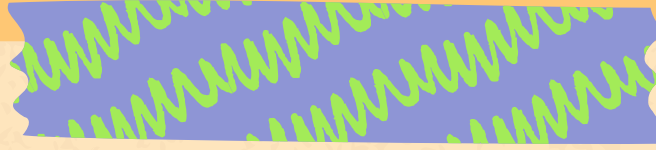
Automatically Collected Data

- IP address, browser type, and device information*
- Website usage data via cookies (see our [Cookies Policy])*
- Referral URL and browsing behavior*

Blockchain Data

- Wallet addresses and transaction history may be publicly visible on the blockchain. We do not control or alter blockchain data.*

2. How We Use Your Information

We use your information to:

- Facilitate token purchases, staking, and platform access
- Provide customer support
- Send important updates (e.g., presale announcements, security notices)
- Analyze website performance and user behavior
- Comply with legal obligations and enforce our Terms

3. Legal Basis for Processing (EU/EEA users)

We process your data under the following lawful bases:

- Consent (e.g., when you subscribe to updates)
- Contractual necessity (e.g., to deliver services you requested)
- Legal obligation (e.g., fraud prevention, compliance)
- Legitimate interest (e.g., platform analytics)

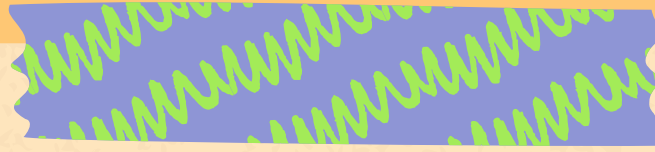
4. Sharing Your Information

We may share your information with:

Depending on your location, you may have the right to:

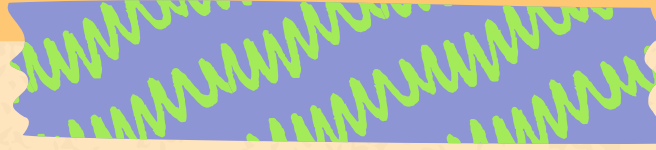
- Access, update, or delete your personal information
